**SPECIAL PROVISIONS**

- Display clean red flags not less than 18" square and fastened to staffs of sufficient length so as to permit the flags to move freely of any obstructions, located as follows: One at each end of the front bumper at a 45 degree angle, one at each end of the four corners of the vehicle or load, and if there is any part of the load wider, one at the widest point on either side.
- One vehicle escort (minimum).
- Two vehicle escort (minimum).
- \_\_\_\_\_ vehicle escort (minimum).
- Movement is restricted \_\_\_\_\_.
- Oversize Load" signs to be attached to front and rear of vehicle and load.
- Vehicle not to exceed \_\_\_\_\_ miles per hour at any time during movement.
- All weights (axle and gross) must be legal or less in accordance with Section 5577.04, Ohio Revised Code. Reduction in legal weight posted on roadways or bridges must be obeyed.
- Applicant must call prior to move to be sure of condition or road to be traveled.
- Applicant must notify proper Delaware County representative at (740) 833-2439 at least four (4) hours prior to a move or before 10:00 a.m. on Friday if move is to be made on weekend. Notification must be made during normal working hours.
- Any obstruction to the movement, such as mail boxes, signs, etc., which are removed by the permit holder to facilitate the move, must be put back in place immediately after the movement has cleared the obstruction. When trimming of trees is required to accommodate the move, the applicant shall obtain permission from all necessary parties and shall be responsible for resolving all claims from damage related to the move.
- Applicants are advised that these permits cover only unincorporated Delaware County and Township maintained highways and structures including County maintained structures on township roads. Permits to move over all other roadways not part of the Delaware County and Township road system must be obtained from the proper authorities. Permits to move over municipal highways must be obtained from applicable municipality if so required.
